Further to RFP Document (Ref No- No.DUA/P/7/2016/5,dtd.01.09.16), amendments are notified as below. All other requirements / specifications / information / Terms and Conditions shall remain unchanged except as given below:

1. Page no 9, 12.Earnest Money Deposit (EMD) and Bid Processing Fees, point 12.1 (I) stands amended as below:

“An EMD of ₹ 2,00,000.00 (Rupees Five Lakhs only)” may be read as “An EMD of ₹ 2,00,000.00 (Rupees Two Lakhs only)”

2. Page no. 17, Procedure for Detailed Evaluation of Technical Qualifications ,Point 1 stands amended as follows:

“Minimum Average Turnover of Indian Rs. 10 (Ten) crores” may be read as “Minimum Average Turnover of Indian Rs. 5 (Five) crores”

4. Page no 19, point no (c), Table for evaluation of each key professionals the following criteria stands amended as below:
“Experience of Urban Sector projects in State”, may be read as” Experience of Urban Sector projects in North Eastern Region”.

5. Page no 24, Form 2B stands amended as below:
“Net Profit” may be read as “Net Income”.

6. Page 41, Form Fin-3, point no 3, stands amended as below:
Point number 3 “Indicate separately staff month rate for each activity separately” stands deleted.

7. Page 42, Form Fin -4 , stands amended as below:
The statement “(To be customised by the State as per the requirement. The assumption is based on 42 months with 1 office. The quantity to be corrected as per the State)” stands deleted.

8. Page no 86, Liquidated damages,9.2, stands amended as below:
Under Liquidated damages point no 9.2 may be read as “The amount of liquidated damages under this contract shall not exceed 10 % of the total value of contract as specified in Appendix D”.

9. Page No 88, SC clause 3, Ref. of GC Clause 1.8, stands amended as below:
For the “Employer” Urban Affairs Department, Government of Meghalaya.

10. Page No 89, SC Clause 7, GC clause 2.4, stands amended as below:
“The time period shall be 42 months”.
