
ADVERTISEMENT

A Special Camp to issue and receive applications in the prescribed format for registration of street vendors will be held from the 14th to 19th December 2016 at the office premises of the Shillong Municipal Board, Bishop Cotton Road. All persons whose sole source of livelihood is from street vending in the Shillong Municipality, Mawlai, Mawpat, Nongmensong, Pynthorumkhrah, Nongthymmai, Umpling, Madanrting, Lawsohtun, Umlyngka and Nongkseh are invited to attend the said camp from 10:30 AM to 2:00 PM on the dates mentioned above.

Application forms will be issued and received only during the dates specified above.

GENERAL INSTRUCTIONS

1. Only one person from the same household is eligible to apply. If more than one application is received from the members of the same household, only the application by the head of the household will be accepted.
2. The applicant should be a citizen of India and a registered voter of the State of Meghalaya.
3. Mere submission of the application does not entitle the applicant the right to be registered or to carry out any vending activity.
4. The application will be subjected to a verification process for final registration.
5. These documents in original along with a photocopy, shall be produced at the time of submission of the application forms:
 - a. EPIC
 - b. Passport size – photographs – 2 nos
 - c. Ration Card/BPL card/Family Identity Card




